1	Minutes from previous meeting Proposed Julie Morrison Seconded Dougie McCallum
2	Police Scotland  None present. It would appear that we may no longer be on their agenda.
3	Planning/Licensing There was no new news to report regarding the houses on Mount Vernon Avenue other than the significant amount of objections lodged will probably mean that this application will not be passed without further discussions.
4	Councillor  Potholes in Thornbridge Rd – arrangements have been made for repair but dates not yet known.  Potholes at Dolan St/ Greenshields Rd, Thornbridge Roundabout/Maxwell Dr & Hathersage Ave – await update  Lights R1, R4 & opposite R5 in Garrowhill Park await repair. Lighting faults can be reported on 0800 353634 option 2.  Requests for bins on Gargrave Avenue, Burntbroom Drive & Thornbridge Rd (in lieu of lamppost bin) – will be actioned & sited as requested.  Request for grit bin Beech Avenue – LES have been contacted again regarding the issue for elderly residents. Await update.



### JOHN MCEWAN, MURRAY PACKER & DOUGIE MCCALLUM PLEASE NOTE:

A site visit was been requested re the traffic issues in Bowes Crescent & Gargrave Avenue since the monitoring cables had been broken during this survey. Dates of 14<sup>th</sup>, 17<sup>th</sup> & 21<sup>st</sup> January were offered by LES with 17<sup>th</sup> at 8.30am being chosen.

Murray noted that drain at corner Gargrave Ave/Bowes Crescent badly needs cleaned – nothing discussed

Junction at Gargrave and Mt Vernon Ave flooded – nothing discussed

Bus stop flooding at bottom of Hillsborough –arrangements have been made for investigation to take place and a report provided when available.

Flooding on Edinburgh Rd – as above.

Barrachnie Park bushes – area to be visited & arrangements made to cut them back (THRIVING PLACES NEIGHBOURHOODS – see below)

Request for a NO DOGS sign in Garrowhill park toddler area – await update.

THRIVING PLACES NEIGHBOURHOOD is joint initiative between LES & Jobs and Business Glasgow with regards to green spaces in a number of our Thriving Places Neighbourhoods. They have recruited 35 trainees who will work under the supervision of LES and will undertake important tidying work – shrub & hedge pruning, edging, trimming, delittering etc. We can request any particular greenspace work to be tackled.

## 5 Roads & Lighting.

There is mixture of street lighting on Mount Vernon Avenue on the new lampposts erected.

Mount Vernon Avenue is in need of total resurfacing.

- **Sherbourne Park** L H path is not getting done due to no money now available as the wrong path (R H) was laid due to an error by the contractor. This should be covered by the contractor but appears not. Flooding was also promised to be rectified but nothing done.
- **AOB** children from new Garrowhill (south of Glasgow Road) are not in the catchment area for Garrowhill Primary although those from Coatbridge & Easterhouse are if they have a granny or other relative in the area
